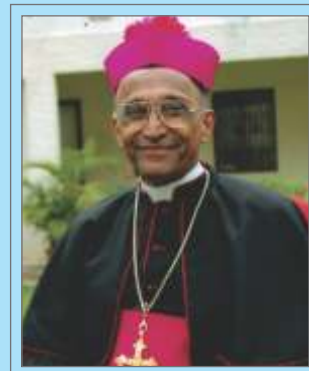

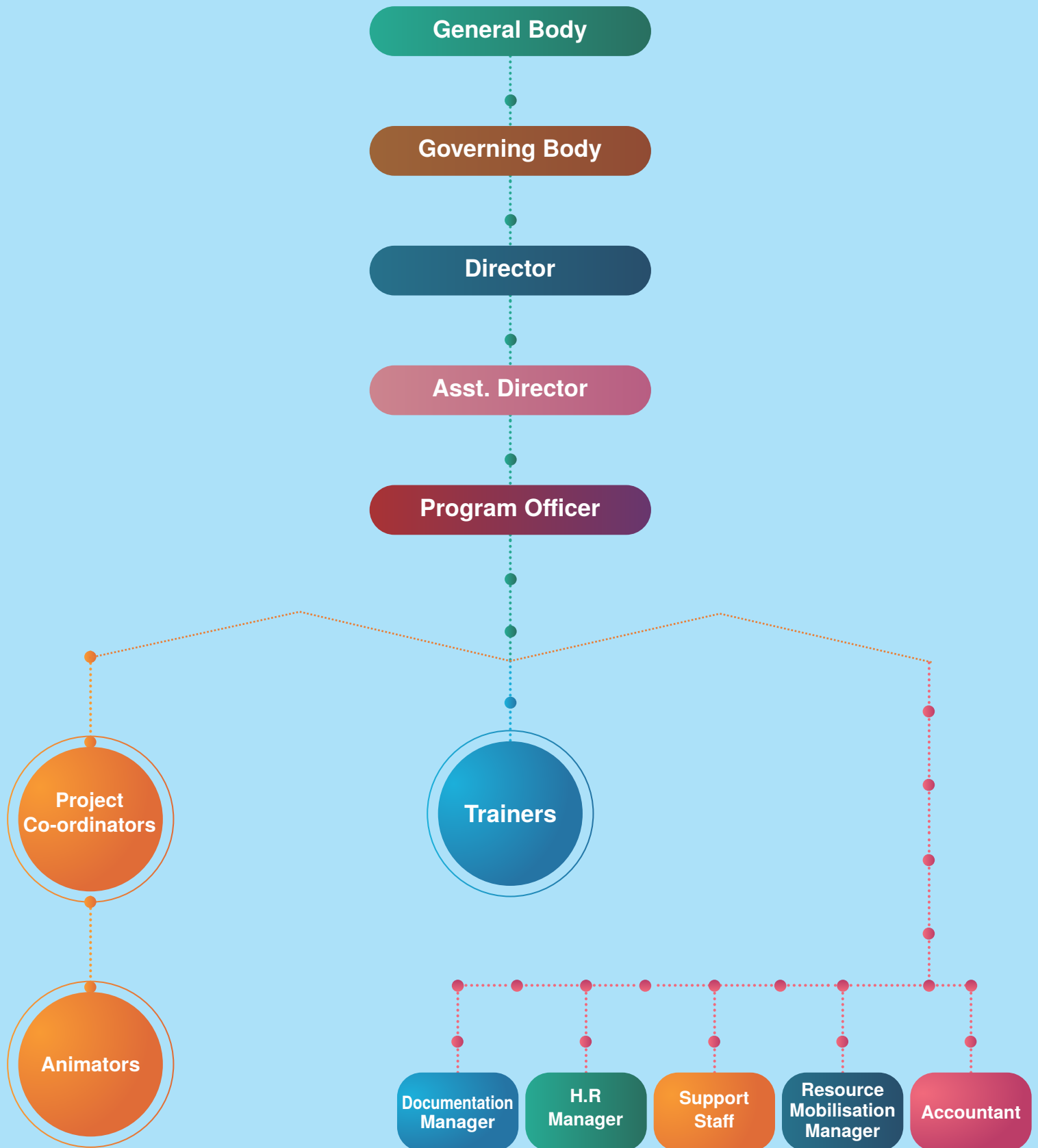

## PROFILE OF THE ORGANISATION

BMSSS is the social concern and development wing of the Catholic Archdiocese of Bangalore. Established in the year 1969 and registered under Karnataka Societies Registration Act 1960 (Reg. No. 117/69-70). BMSSS is a secular, non-governmental, not-for-profit organization for the uplift of the marginalized Women, Children, Youth, Farmers, the Sick and the Suffering. The organization works especially for the development of Dalits and Minorities. BMSSS is registered under 12A and 80G under income tax department. It is also registered with NITI AYOOG and Ministry of Home Affairs of the Government of India.

## OPERATIONAL AREA

Geographical area of Catholic Archdiocese of Bangalore is the operational area of BMSSS. The Archdiocese of Bangalore has jurisdiction over the districts of Bangalore Urban, Bangalore Rural, Tumkur, Kolar, Ramanagara, and Chikkaballapur in Karnataka state.

# PROGRAMMES IMPLEMENTED

## 1. PROMOTION OF WOMEN ENTREPRENEURSHIP

The project “Promotion of Entrepreneurship among Economically Disadvantaged Women in KGF” was financially supported by Manos Unidas, Spain. It was implemented among SHG women in Kolar Gold Fields (KGF) in the district of Kolar of Karnataka state. The main objective of the project was to increase the number of Women Entrepreneurs and ensure sustainable livelihood through small businesses.



Apart from TRAINING ON ENTREPRENEURSHIP, the women were also trained on Human rights with special focus on Rights of Women, Leadership among Women, Health Issues, SHG Sustainability, Models of SHG Documentation, Panchayat Raj Institutions (PRIs), Water Conservation, Rain Water Harvesting, and Kitchen Garden Maintenance. The women were also given awareness on newly available Govt. schemes. 2869 women participated and benefitted from the trainings.

**Trained to become self-confident, not depressed**

48 year old Shashikala belongs to “Kanika Madha” Self Help Group (SHG) which was formed by BMSSS in 2016 at Gilbert’s Block in Kolar Gold Fields (KGF) in Kolar district. When her husband died 15 years ago, she was mother to two young children. With much hope Shashikala became an active member of her SHG. To build her self-confidence, she regularly attended SHG meetings and participated in all trainings offered by BMSSS. As an active SHG member, she did regular weekly savings. After being a SHG member for six months, she became eligible for a loan. With a small loan from her SHG, she started preparing breakfast and snacks in the evening for sale to maintain her family. She has now overcome her depressed status. Previously, she had no knowledge about sustaining her family and sending her children for school education. Although she wants to buy a gas stove, she presently manages her small business of preparation and sale of food items by using kerosene stove and sometimes firewood. With SHG loan, she is now capable of securing her means of livelihood and was able to overcome her depression.

**Exposure visit for SHG women**

The women entrepreneurs were given opportunity to visit other women in micro enterprise to learn for themselves how other women manage small business. During exposure visit, the women got to learn trades such as candle making, knitting, and leather bag making. How small businesses are carried out by destitute women specially impressed the visitors.



## 2. TWINNING PROJECT- CAPACITY BUILDING OF SHGs

KOLPING INDIA has been working for many years with BMSSS to develop the capacity of women in the Archdiocese of Bangalore by forming Self Help Groups (SHGs). They are working in 45 villages in Bangalore Urban, Bangalore Rural, Kolar and Tumkur districts in Karnataka. Today, 1190 members exist in 72 Self Help Groups (SHGs) in 4 districts of the Archdiocese of Bangalore with a total saving amount of Rs.72,77,020/- (Rupees seventy two lakhs seventy seven thousand and twenty).

### **Trainings**

In 2017-2018, with the support of external resource persons, new and old SHG members underwent trainings on Life skills, Human Rights, Panchayat Raj Institutions (PRIs), Govt. Welfare Schemes, Participatory Rural Appraisal (PRA), Advocacy and Lobbying, Health and Sanitation, Entrepreneurship Development, Household Finance Management, Group Management, Leadership, Documentation, Nutrition, Communicable Diseases, and Networking. Over 1000 SHG members participated in the resource talks and benefitted from it.



### **Exposure Visit**

Apart from training to SHG members, 18 Village Level Kolping Federation (VLKF) members were assisted to visit two SHG federations in Chennai. Their visit to Avadi Kolping federation and Villivakkam Vattara Magalir federation of Madras Social Service Society helped them learn regarding structure, administrative system, and economic activities of federations. The participants were inspired by the financial achievements of SHG women and decided to implement similar activities in the newly formed SHG federations and Village Development Committees (VDCs) in Kolar district.

### **Children's Camp**

117 children from Kolar district participated in Summer Vacation Camp. 97 children attended awareness camp at Victories church at Champion Reefs. The camp enlightened children on the Right to life, Development, Care, Protection and Participation. The activities such as Drawing Competitions, Training on Arts & Crafts encouraged children to get in to innovative ideas.



### **Networking & Linkages**

55 members participated in interface meeting with local institutions and NGOs. Networking and linkage with Global Hospital, Bangalore, MEDCIS, Ambedkar Academy and Lions Club helped elderly people undergo general health check-up, free eye check-up and availability of spectacles. The physicians from hospitals provided health awareness to elderly people on kidney and liver problems.

## Credit Activities of Twinning Project

The SHG women are trained to start their own businesses for income generation. After training, the women are financially supported by Kolping India through BMSSS to start IIGP (Individual Income Generation) activities. Women get micro-credits not only for income generation but also for vocational training of children, purchase of milch animals, construction of toilets and building low cost houses.

## From hardship to happiness

Livelihood problem of Elizebeth Rani from Pavanamathe SHG at Sannenahalli village in Tumkur district was discussed in one of the meetings and a solution was sought for. Discussion of livelihood problems of members of Kolping family is a regular feature in their weekly meetings. Her husband is an agricultural labourer who is above 60 years old and unable to work hard. Her son is a daily wage labourer not getting regular work. Income from their work is insufficient for the maintenance of the family. They regularly face a lot of problems to avail necessary medicines and food for the family. In the meeting, the members suggested Elizabeth to start a Photo copying cum Printing business as the people of the village have to travel 20 kms to the neighbouring town to avail the facility.

Training on Govt. schemes introduced Elizabeth Rani to 'Shramashakthi' loan scheme from the Minorities department of the Karnataka government. She applied and received a loan of Rs. 50000/- to purchase a Xerox and photo printing machine. Electricity failure on a day-to-day basis became another added problem that affected family livelihood and loan repayment. Kolping members discussed the problem and agreed to give Elizabeth Rani Rs. 10000 as loan to purchase a UPS in response to regular power cut to run her small business. The loan from Kolping India through BMSSS saved Elizabeth Rani and now she is earning Rs.10000 per month. A family that was sinking economically with very low monthly income for the maintenance of the family is now a happy family with good profit from a small business.

## Women take steps to form Village Development Committee

SHG women of Kolar Gold Fields (KGF) in Kolar district met local village leaders and the local Govt. staffs to discuss about village problems. In the meeting, the women informed the participants that they already conducted a Participatory Rural Appraisal (PRA) and identified a number of village issues that evaded solutions for a long time. They stressed that open defecation, water distribution and drainage systems were some of the serious problems that need immediate solution. They informed the panchayat officials and local leaders that open defecation affect safety and security of women, especially teenage girls.



The women decided to form Village Development Committee to take all development activities of the village into their own hands. The Committee approached Govt. officials in the panchayat and managed to get nine individual toilets constructed. They also informed the Panchayat officials that drainage system in their villages is in shambles and it is necessary for the government to provide proper facilities for the people. The women realized that the problems are no more to be shelved under the bushel when solutions can be found through women's gatherings for noble causes.

### 3. WOMEN EMPOWERMENT

The project “Women Empowerment” supported by Misereor through KROSS is implemented in 78 villages of Mulabagilu and Srinivasapura taluks of Kolar district in Karnataka. The project aims at the development of women by organizing them into taluk and district level federations of Self Help Groups (SHGs).

The objective of the project is that the SHG women of the target villages and their federations are trained to affirm their rights by availing their entitlements in the field of health, education, income generation activities and political participation. They are also empowered to ensure reduction of violence against them at least by 60%, get legal remedies to ensure prosecution of culprits, to prevent atrocities and violence against them, lobby for Govt. Policies and Schemes in favour of women.

Towards achieving the project objectives, trainings are conducted for women SHGs and their federation such as Panchayat Raj Institutions (PRIs), Gender Equity, Women's Rights, Advocacy, Lobbying, Leadership, Communication skills, Fund Raising Strategies, Right Based Approach, Right Based Management and various Govt. Laws.

## 4. SURAKSHA – HEALTH & SANITATION PROJECT

Kolar Gold Fields (KGF) is known for lack of health and sanitation as people live in old and dilapidated houses. In the area, people of all walks of life get affected by pollution, migration, alcoholism, malnutrition, unhealthy practices and life style diseases. The project 'SURAKSHA' is being implemented in 15 lanes of Champion Reefs in KGF in collaboration with Caritas India. It aims at sensitizing the community on different aspects of health and sanitation by generating motivated and committed local volunteers during the project period.

In preparation to start 'SURAKSHA' project, a preliminary survey was conducted in 15 blocks. As part of Rapid Rural Appraisal (RRA), the local leaders were interacted and discussed about the Existing Drainage System, Public Toilet, and Garbage Disposal Methods. The result of the survey included 2957 families, 20 public toilets, 286 individual toilets, 5 water source and 832 open defecation.



Health and Sanitation program was inaugurated at champion reefs, KGF, in the presence of over 300 people. The resource people enlightened the crowd with health related topics such as Homeopathic medicine, Kitchen Garden, Rain Water harvesting and safe drinking water. They insisted to grow and nurture at least one tree to protect our environment which is rapidly deteriorating. The members actively participated in the program and became volunteers to support for noble cause.



## 5. EMPLOYABLE SKILL TRAINING

Employable skill Training was aimed at providing job oriented trainings to the unemployed and school dropout young boys and girls in the archdiocese of Bangalore. The young boys were assisted to train themselves to become professional drivers. They became capable of being self-employed as taxi drivers with assistance of bank loans. They could also seek employment as professional drivers in travel agencies. The girls were trained in tailoring to be self-employed in their own places.

141 untrained school dropouts and unemployed youth were introduced to the new skills like Garment Making and Four Wheeler Driving to make their life brighter with employment. Caritas Hradec Kralove supported trainings for these youngsters. While 61 boys became professional drivers, 80 girls learned tailoring and earned income for their families. They became respectable persons in society and role models to other unemployed men and women of their locality.

**Tailoring:** After completion of six months course, a test was conducted and certificates were distributed with a tool kit to help them for their future work.

**Four Wheeler Driving:** Training on Four Wheeler Driving was conducted in the Rural and Urban areas of Archdiocese of Bangalore. There were 61 trainees of Four Wheeler Driving who were trained by instructors.

The Four Wheeler Driving Trainees after completion of Four Wheeler Driving the trainees received their licenses as professional drivers. Some of them started working as drivers in companies and earning decent salaries to support their families.



## 6. TUITION CENTERS

Tuition centres for school going children emerged in some remote parishes of Bangalore Archdiocese with the financial support of ASHA Trust. John Dewey says, “The most important attitude that can be found is the desire to go on learning”. Children were very happy and delighted to come back to their Tuition Centers. Children have improved their academic excellence and their social skills through tuition classes. These special Learning Centers help the economically poor children develop interest towards their studies. These Centers also provide an opportunity to children to explore their hidden talents and skills. In the words of Shri APJ Abdul Kalam, “Learning gives Creativity, Creativity leads to Thinking, Thinking provides Knowledge, and Knowledge makes you great”. Tuition Centers have become a channel for children to become creative thinkers and to become someone great in the society. Children have learned to be innovative in their studies and to utilize their time in a fitting manner. Through tuition centers, children showed great interest in studies as well as in extracurricular activities like Dance, Singing, Mono Acting, and Sports. They have become supportive to their teachers and parents at home. Teachers have played an important role in the lives of children with their loving approach and making children get good results in examinations. Tuition for school going children has two main objectives:

1. Motivate the economically backward parents about Child Rights with special focus on children’s right to education
2. Help weak students get better academic performance through evening tuition

Orientation to parents on Archdiocesan scholarship for education of children, sports for children, Distribution of prizes and certificates, awareness to parents on child nutrition/health/sanitation and Christmas gathering were other activities of the project.



During the academic year 2016-2017, there were 12 old centers and 08 new centers to provide tuition for children.

**Sports Day:** The Sports Day for children was organized as part of tuition centers. The presence of parents of children on sports day was a support for children. The parents expressed their joy and support for Tuition Centers and encouraged us to go further in the efforts. On the day of the event, parents were given awareness on Children's Health and they were also made aware of the importance of common diseases and personal hygiene.

On sports day, prizes were given to children who won the competitions in games and sports. The best students in each tuition center were given prizes and regular attendance for tuition classes also won prizes. The presence of parents during prize distribution encouraged children to give better performance in future.

## 7. HIV/AIDS EDUCATION AND AWARENESS

In 2017 and 2018, BMSSS implemented HIV/AIDS Education and Awareness project for students in Kolar district with the financial support of Kindermissionswerk, Germany. Various methods to prevent the killer disease were imparted to students through talks, rallies, and competitions. BMSSS project staff worked meticulously in identifying infected patients and referred them regularly to DAPCU (District AIDS Prevention and Control Unit) to avail free ART (Anti Retro-viral Therapy). The project motivated local people for annual observation of “WORLD AIDS DAY”.

### OUTCOME:

- Over 6000 Students, Parents, Teachers, Women SHG Members and Local Organizations of Kolar district benefitted from the project.
- After Spreading awareness to parents and SHG members around 600 Men, 450 women and 80 children approached ICTC (Integrated Counseling & Testing Center) for counseling and blood testing. All of them were found positive and were put under medication.
- 150 Children from 22 schools came forward to form HIV club to spread awareness to the public through rallies and classroom sessions.
- 55% students speak openly and share about HIV/AIDS, Topic of Sex, interpersonal problems and discrimination with their teachers and counselors.
- 80% of the teachers give positive support and full cooperation in conducting programs related to HIV/AIDS in schools and in the local area.
- Voluntary service through like minded organizations in terms of resource talks, new strategies etc. were given in implementing programs to schools and colleges.

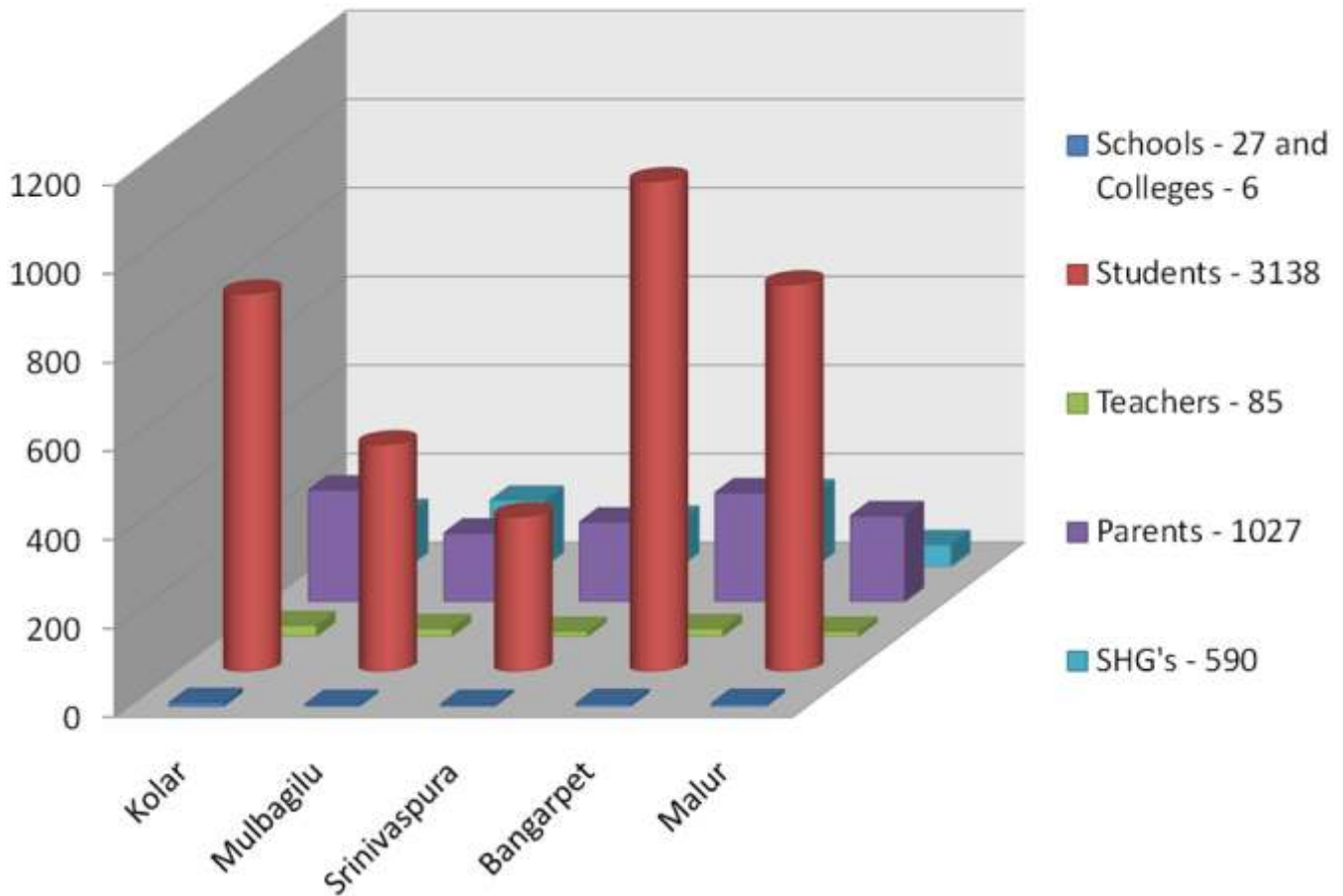

### MANOS UNIDAS TEAM VISITS

On 22nd November, 2017, Ms. Alexandra Garcia and Ms. Ana Luna of Manos Unidas, Spain, visited field area of BMSSS in Kolar Gold Fields (KGF). At the start of the visit, they interacted with the director and the former director of BMSSS and BMSSS staffs. During the day, they reached out to project beneficiaries at Champion Reefs in KGF to know more about the welfare of their families. They asked them about income generation activities of Self Help Groups (SHGs) of women in their area. Afterwards, the visitors went around visiting houses of SHG members in two locations. While interacting with SHG members, some of the successful women entrepreneurs shared their experiences about the advantages of being part of a Self Help Group (SHG). The women spoke specially on benefits of trainings they received from BMSSS and the small businesses with which they are able to manage with the help of trainings. Women organised an exhibition of products which they make as part of their income generation activities. The women took the visitors around the exhibition hall and explained to them how various products are made and marketed.



### A VISIT FROM OFFICIALS OF CARITAS HRADEC KRALOVE

On 24th and 25th November, 2017, the Officials of Caritas Hradec Kralove of Czech republic, Fr. Josef Suchar, Mr. Vojtech Homolka, Ms. Evazalesakova, Ms. Ludmilla Rychlaro and Ms. Marcela Hledikov visited both Devanahalli and KGF areas of the Archdiocese of Bangalore. They expressed their interest in meeting some of the successful youngsters who underwent training in job oriented courses both in Four Wheeler Driving and Tailoring. During their visit to ASHA Office in Bangalore, they understood better how the Archdiocese of Bangalore works for skill training of the youth in collaboration with Caritas Hradec Kralove of Czech republic.



Caritas Officials also interacted with the beneficiaries to know how the skill training helped them improve the income of their families. They learned from the beneficiaries that the financial support from Caritas Hradec Kralove helped many youngsters undergo employable skill training courses to earn substantial monthly income for their families. Boys, who joined a driving school, are presently driving vehicles of reputable private companies and girls who underwent Training in Tailoring are able to start independently their own home business in tailoring.


